

ARTICLES OF INCORPORATION

OF

PARKS TAE KWON DO ACADEMY, INC.

The undersigned incorporator, for the purpose of forming a corporation in accordance with the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be PARKS TAE KWON DO ACADEMY, INC.

ARTICLE VII. BOARD OF DIRECTORS



ARTICLE IX. AMENDMENT


