The undersigned incorporator(s) hereby adopt the following Articles of Incorporation:

- I. CORPORATE NAME - COAST TO COAST TRANSPORT, INC.

- VI. EFFECTIVE DATE - The effective date of this incorporation shall be MAY 17, 2000.

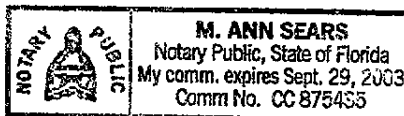
