The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the law of the State of Florida.

**ARTICLE I**

**NAME**

The name of the corporation is VISION-VICTORY, INC.

**ARTICLE II**

**PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III**

**DURATION AND COMMENCEMENT OF CORPORATE EXISTENCE**

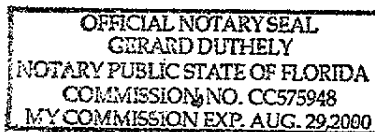
