#### **ARTICLE ONE**

#### Name

The name of this corporation is SAVE24seven, Inc. The mailing address of the Corporation is Post Office Box 15636, Sarasota, Florida 34277.

#### **ARTICLE TWO**

#### Term of Existence

The date when corporate existence shall commence shall be the date of filing of these articles and the Corporation shall have perpetual existence thereafter.

#### **Nature of Business**

- (H.) to make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income;


