## ARTICLES OF INCORPORATION MOTIVATED SPORTSMEN OF ALABAMA, INC.

ALL MARCHANIST OF THE PARTY OF The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I - NAME AND ADDRESS
