The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the corporation, hereinafter referred to as the "Corporation" is Busy Beaver, Inc.

The Corporation shall exist perpetually unless dissolved according to Florida law.




