The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. Name

The name of the corporation shall be Skylake Building Cleaning, Inc.

Article II. Principal Office

The principal place of business and mailing address of this corporation shall be 18401 Northeast 20th Place, North Miami Beach, Florida 33179. Its business shall be carried on in the State of Florida, in the United States of America and elsewhere, as may be authorized by its Board of Directors or Stockholders.

Article III. Purpose

The general nature of the business to be transacted by the corporation shall include any and all lawful business with all powers conferred upon Corporation by the Laws of the State of Florida. The corporation may NOT adopt, change, amend and repeal By-laws, consistent with law or its Certificate of Incorporation, for the exercise of its corporate powers, the management, regulation and government of its affairs and property, the transfer of records of its stock or other evidence of interest or membership, and the calling and holding of meetings of its Stockholders, except by a unanimous vote of its Stockholders and by a unanimous vote of its Board of Directors. The corporation may NOT increase or diminish, by vote of its Stockholders, Shareholders, or members, cast as the By-laws may direct, the number of Directors of the Board of Directors or trustees. Further the corporation may only make and enter into all contracts necessary and proper for the conduct of its business by a unanimous vote of its Stockholders and by a unanimous vote of Board of Directors.

Article IV. Shares

The number of shares of stock that this corporation is authorized to have outstanding is One-Hundred shares of One (\$1.00) par value. Initially, same shall be distributed 100% to Raul F. Gonzalez.

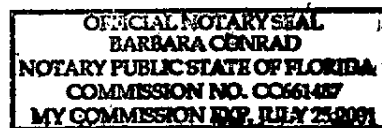
