**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is LOWELL AT WHITEHORSE, INC. (the "Corporation"), Charter #P00000053672, filed on June 2, 2000.
2. The following Amendment to the Articles of Incorporation was adopted by the sole Director of the Corporation and the sole Shareholder of the Corporation, the number of votes cast being sufficient for approval, on August 28, 2000 in the manner prescribed by Section 607.1003 of the Act:


**ARTICLE I**
