Attached, please find our check in the amount of \$150.00 and the signed Uniform Business Report. The report is being submitted late under circumstances which were completely out of our control. Once the circumstances are explained, we will ask for your understanding and cooperation in accepting the report without the normal late charges.

We have just opened an upscale coffee shop in the International Plaza in Tampa, Florida. The facility has been under construction for over a year. We formed the company to operate the business within the confines of the International Plaza property, therefore, the address of the business was our location inside the Plaza. The post office boxes for mail delivery were the last of the finishing touches to be completed and the keys to the boxes were distributed after the Plaza opened in September 2001.

We never received the original Uniform Business Report. We believe that the US Post Office held the mail for a period of time then returned it to Tallahassee as undeliverable because the mailing address did not exist in January 2001 when the reports are mailed from Tallahassee. It was only after we received the reinstatement notice did we know that UBR should have been filed by May 1, 2001 and we missed the deadline.

-So, I hope you understand that this delinquency was out of our control. The extra cost for late filing and reinstatement under normal circumstances would not be as major a burden as it is to our startup company now. We opened the shop just before the tragedy of September 11 and since then our sales have been down tremendously because the people of the area refrained from shopping and the state of the economy is not helping either.

As we struggle to keep our door open and our employees employed, we ask you for your assistance and understanding. Please process this UBR so we can put this worry behind us.
