The undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I
NAME OF CORPORATION**

**ARTICLE II
PURPOSE OF BUSINESS**

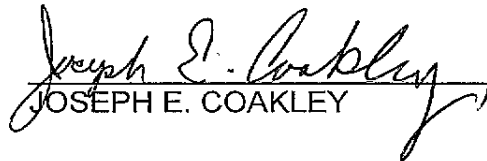

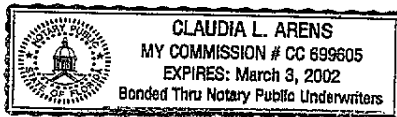
