# ARTICLES OF INCORPORATION

#### <u>OF</u>

#### THE BRUCE GROUP. INC.

WE, the undersigned, hereby act with the purpose of effecting a corporation under the laws of the State of Florida, by and under the provisions of Chapter 607, of the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

#### ARTICLE I

#### NAME

The name of this corporation is THE BRUCE GROUP, INC.

# ARTICLE II

This Corporation shall exist in perpetuity commencing on the date of filing of these Articles of Incorporation by the Secretary of State

### ARTICLE III

# NATURE OF THE BUSINESS

This Corporation is formed for the specific purpose of being engaged in any business, as allowed by law, to the public wherein the nature of this said business is only as it is licensed for the state services provided under the laws of the State of Florida.

#### ARTICLE IV

The aggregate number of shares which this corporation is authorized to issue shall be One Hundred. Such Share shall be of a single class and shall have a par value of One Dollar per Share, which shall be designated "Common Shares".

The affirmative vote of two-thirds of the Shares of this corporation, represented at a meeting at which a quorum is present, shall be required to amend these Articles of Incorporation so as to increase or decrease the authorized number of shares, or change the designations, preferences, qualifications, limitations and restrictions; or to merge or consolidate the corporation with or into any other corporation; or to sell, lease, or convey all or substantially all of the assets of the corporation, or voluntarily to dissolve, liquidate, or wind up its affairs.

#### ARTICLE XI

This corporation will indemnify any person(s) who was or is a party or is threatened to be made a party to any suit or proceeding(s) by reason of the fact that they are or were a director or officer of the corporation, against any and all expenses, judgments, and amounts paid in settlement incurred by them in connection with such action, suit or proceedings, except for an officer or director who is adjudged guilty of willful misfeasance or willful malfeasance in the performance of their duties.
