ARTICLES OF INCORPORATION
OF
INTERNATIONAL ACADEMY OF DESIGN - ORLANDO, INC.

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation is: International Academy of Design - Orlando, Inc.

SECOND: The principal place of business and mailing address of the corporation is 1011 Wymore Road, Winter Park, Florida 32789.

THIRD: The purposes for which the corporation is initially organized, which shall continue to be the purposes of the corporation until and if the same shall be amended pursuant to the provisions of the Florida Business Corporation Act, and which shall include the authority of the corporation to transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act, are as follows:

1. To own and operate a school providing academic instruction in the fields of technology and design; and
2. To have all of the powers conferred upon corporations organized under the Florida Business Corporation Act.

FOURTH: The number of shares of stock which the corporation shall have authority to issue is one thousand (1000), all of which are without par value and are of the same class and are to be Common shares.
