ARTICLES OF INCORPORATION
OF

DOCTOR'S MEDICAL & OSTEOPATHIC CENTER, INC., a Florida Corporation

The undersigned, acting as Incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is DOCTOR'S MEDICAL & OSTEOPATHIC CENTER, INC.

The mailing address for the principal office of this corporation is P.O. Box 130, Old Town, Florida 32680-0130.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, and shall be in existence upon the filing of these Articles with the State of Florida.

ARTICLE III

PURPOSE

The Corporation is organized for any lawful purpose permissible under the laws of the State of Florida and under the laws of the United States of America.

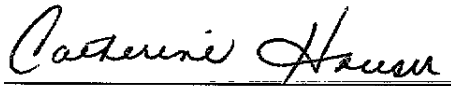
