**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of corporation:

ARTICLE I NAME AND ADDRESS

The name of the Corporation is : LA DETENTE DES ARTS RESTAURANT INC.. The principal office is: 7529 W. Oakland Park Blvd., Lauderhill, Florida 33319.

ARTICLE II -DURATION

The duration of the Corporation is perpetual

ARTICLE VI- INITIAL BOARD OF DIRECTORS




