Our office recently received a Uniform Business Report from your office. Upon review I discovered that it was a second notice which included a \$400 late fee. It is, however, the first report of it's kind our office has ever received. Having only been incorporated since June 2000 it is the first time we've seen or heard of the Uniform Business Report. I called our accountant, as I do with all new unfamiliar documents, who explained what it was and when we should have received the first one and then called your office to find out what to do.
