ARTICLES OF INCORPORATION OF CITY TIRE KENDALL FALLS, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I NAME

The name of the Corporation is City Tire Kendall Falls, Inc.
