

ARTICLES OF INCORPORATION TESOREX CORPORATION



WE, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the Laws State of Florida and, under the statute of the State of Florida providing for the formation, rights, privileges, immunities an liability of incorporating for profit it is:

ARTICLE I

The name of the corporation shall be: Tesorex Corporation

ARTICLE II

The corporation shall engage in any activity or business permitted under the Laws of the State of Florida and the United States of America. Particularly, it will engage in providing Web Design, and Web Hosting Services, Solutions for Internet and Commercialization of Products for Internet; E-commerce, Data Base Solution, Application and Software Development, Graphic Design, Video and Graphic Animation, Import and Export of this products and others.

ARTICLE III

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 500 shares, one dollar a share.

The names and address of the subscriber of these Articles of incorporation is Bernardo Gomez, 18349 N.E. 4th Court, North Miami Beach, Florida 33160.

No shareholder of this corporation shall enter into a voting rust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any of all of his shares.

ARTICLE XI

At all elections of Directors of this corporation each stockholder shall be entitled to as many votes as shall equal the number of votes which (except for those provisions as to cumulative voting) he would be entitled to cast for the election of the Director with respect to his shares of stock multiplied by the number of Directors to be elected and he may cast all votes for a single Director or may distribute them among the number to be voted for, or any one or more of them as he may see fit.


