# ARTICLES OF INCORPORATION of THE MARCH GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

## ARTICLE I

# <u>NAME</u>

The name of the corporation is: THE MARCH GROUP, INC.

#### ARTICLE II

## PRINCIPAL OFFICE

## ARTICLE III

## CORPORATE DURATION

The duration of the corporation is perpetual.

## ARTICLE IV

## PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

- 1. To transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
