ARTICLE NINE - INDEMNIFICATION

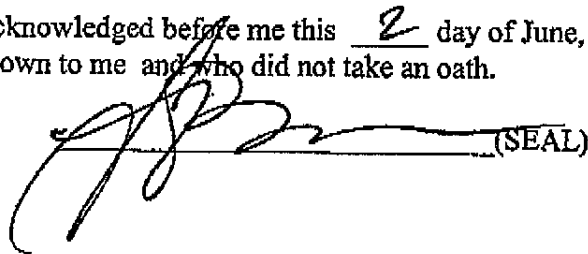

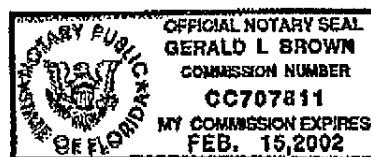
