#### ARTICLE I

The name of the corporation is Bordamar Enterprises. Corporation.

#### ARTICLE II

The main purpose of the corporation is to invest in promising business ventures. Notwithstanding the foregoing, the corporation may engage in any and all activities and businesses permitted under the laws of the United States and of the State of Florida. The corporation shall have all of the powers vested in a corporation organized under and existing by virtue of the laws of the State of Florida.

#### ARTICLE III

The maximum number of shares of stock which the corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock having a par value of \$1.00 per share. Shares held by the initial shareholders and subsequent shareholders may not be resold or otherwise transferred to other persons or hypothecated in any manner unless shares are first offered to the remaining shareholders or to this corporation. The price and terms at which, and the time within which such shares may be offered and sold shall be further specified by written agreement among all of the shareholders of this corporation. The treasury stock of the corporation may only be issued with the approval of the shareholders.

#### ARTICLE IV

The existence of the corporation shall be perpetual. Corporate existence shall commence on the date these Articles are filed by the Department of State of the State of Florida.

#### ARTICLE V

The street address of the principal place of business of the corporation is 881 N.W. 85th Terrace, Suite 1616, Plantation, Florida 33324. The Board of Directors may, from time to time, move the principal office to any other address.

#### ARTICLE VI

The corporation shall have three directors initially. The number of directors may be increased or diminished from time to time pursuant to the Bylaws of the corporation, but shall not be less than one nor more than seven.

#### ARTICLE\_XIII

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.

#### ARTICLE XIV

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors, subject to the approval of the shareholders.

#### ARTICLE XV

The approval of the shareholders of this corporation to any plan or merger shall be required in every case whether or not such approval is required by law.

#### ARTICLE XVI

The shareholders of this corporation shall have the exclusive authority to fix the compensation of the directors of this corporation.
