ARTICLE XI. AMENDMENT

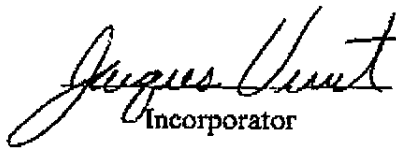

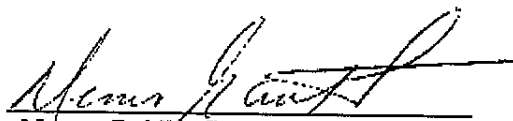
