ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one or more, acting as Directors and Incorporators under the provisions of the Florida Statutes, Chapter 607, adopt the following Articles of Incorporation:

ARTICLE I
Name

The name of this corporation shall be: __

EDGE CONSULTING, INC.

ARTICLE II
Principal Place of Business

The principal place of business is to be located at 7963 Sailboat Key, Boulevard South, #802, South Pasadena, Florida 33707.

ARTICLE III
Term of Existence

The duration of this corporation is to be perpetual.

ARTICLE IV
Purpose

Recruiting and consulting services and generally to do and perform everything necessary for carrying out the aforesaid purposes, and to engage in such other business or businesses, whether related thereto or not, as may be approved by the Board of Directors and which businesses are permitted by the laws of the State of Florida.

Informal Shareholder Action

Any action of the shareholders may be taken without a meeting if consent in writing, setting forth the action so taken, shall be signed by all persons who would be entitled to vote upon such action at a meeting and filed with the Secretary of the Corporation as part of the corporate records.

ARTICLE IX
Directors
