Dear Division of Corporations:


After being out of town for a couple of weeks, I have returned to my office to find a notice from you regarding our Uniform Business Report not being filed. However, this is the first notice I have received about filing it. Unfortunately, we have had some problems with our mail, including not receiving checks from our customers or receiving them in US Postal Service envelopes because they were damaged.

As we have just passed our second-year-in-business anniversary, I have only had to file one Uniform Business Report in the past and am not completely familiar with the process. Had I filed a UBR more than once and been a little more cognizant of its procedure, I would have called the Division of Corporations prior to May 1, 2002 and asked that one be sent to me. However, I have read the notice I received this week thoroughly and now understand that I should expect to receive a notice after the first of each year and that the UBR must be filed by May 1 each year with a \$150.00 filing fee.

I apologize for my lack of knowledge on the subject and assure you that this will not happen again in the future, but had I received a notice prior to this one, the UBR would certainly have been filed on time. Therefore, I respectfully request that you accept this correspondence as notice that your recent request for the filing of our 2002 UBR with a \$550.00 filing fee was the first notice I received, and grant me permission to file the 2002 UBR now with the enclosed \$150.00 filing fee.
