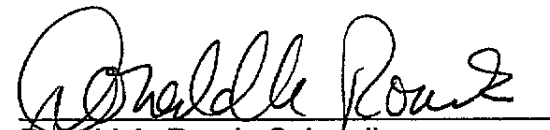
ARTICLE NINE - BY-LAWS

ARTICLE TEN - INDEMNIFICATION

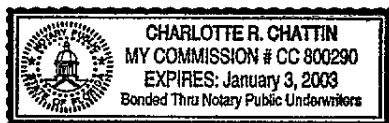

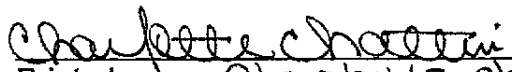

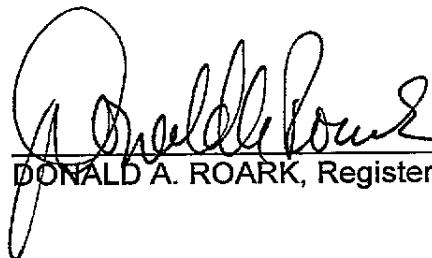
