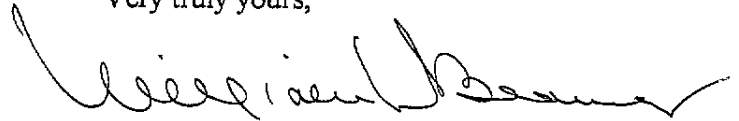

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, Florida Statutes Chapter 621.

ARTICLE I - NAME

The name of the corporation shall be: ZSUZANNA SEYBOLD, M.D., CHARTERED

The principal place of business of this corporation shall be 7145 West Sunrise Blvd., Plantation, Florida 33313.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation. 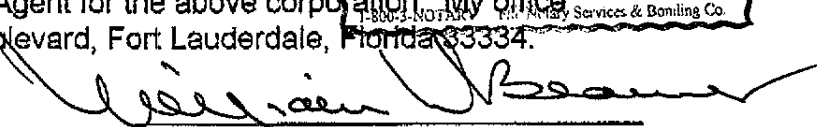
