

# ARTICLES OF INCORPORATION OF AQUA RUSH, INC.



The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the Corporation is Aqua Rush, Inc.

#### ARTICLE II - PURPOSES

#### ARTICLE VII - BOARD OF DIRECTORS
