ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

ARTICLE I NAME

The name of the corporation shall be: Enhancement Technology Group

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- (a) To provide technical consulting and services for the purpose of planning, designing, and implementation of technical solutions.
- (b) To acquire, hold, and dispose of stocks and subscription rights thereto and bonds and other evidences of indebtedness of any corporation; to acquire, hold, and dispose of bonds, mortgages, and assignments thereof; and insofar as it is permitted by law, to purchase, hold, and reissue shares of its own capital stock and its own bonds
- (c) To borrow money and issue evidences of indebtedness to further any or all of the objects of its business; and to secure the indebtedness by mortgage, deed of trust, pledge, or other lien;
- (d) To enter into and perform contracts of any kind necessary or incidental to accomplishment of any one or more of the purposes.
- (e) To make refunds of over-assessments to stockholders, occupants of apartments, or others as provided in the bylaws; and
- (f) To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- (g) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
- (h) In general to have exercise any and all power that corporations have and may exercise under the laws of the State of Florida, specifically including the provisions of Section 607.011 of the Florida Statutes, and as the same may be amended, except such powers as are inconsistent with the express provisions of these articles of incorporation.

ARTICLE IV SHARES

The aggregate number of shares that the corporation is authorized to issue is 300. Such shares shall be if a single class, and shall have a par value of one dollar (\$1.00) per share.

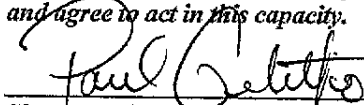
