ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

ARTICLE I NAME

The name of the corporation shall be: Enhancement Technology Group

ARTICLE II PRINCIPAL OFFICE

The purpose for which the corporation is organized is:

- (f) To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- (g) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
- (h) In general to have exercise any and all power that corporations have and may exercise under the laws of the State of Florida, specifically including the provisions of Section 607.011 of the Florida Statutes, and as the same may be amended, except such powers as are inconsistent with the express provisions of these articles of incorporation.
