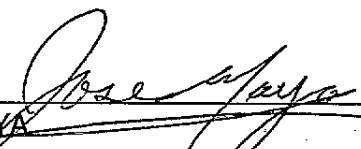
ARTICLE X - INDEMNIFICATION

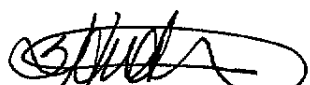
