

ARTICLES OF INCORPORATION OF DEBILIO, INC.

The undersigned incorporator, for the purpose pf forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

Article 1. Name

The name of the corporation is Debilio, Inc.

Article 2. Nature of Business

The corporation is organized to engage in any activity or business permitted under the laws of the United States and the State of Florida.

Article 3. Capital Stock

The original Capital Stock of this corporation shall be one hundred(100) shares of common stock having a nominal or par value of one dollar(1.00) per share.
