**ARTICLES OF INCORPORATION**

The undersigned, an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is Fran-Hall Group, Inc.

SECOND: The street address, wherever located, of the principal office of the corporation is 106 Mc Arthur Avenue, Lehigh Acres, Florida 33972 . The mailing address for the corporation is the same.

THIRD: The number of shares that the corporation is authorized to issue is 100 (one hundred), all of which are a par value of 1 (one) dollar each and are of the same class and are Common shares.

FOURTH: The street address of the initial registered office of the corporation in the State of Florida is 106 Mc Arthur Avenue, Lehigh Acres, Florida 33972.

The name of the initial registered agent of the corporation at the said registered office is Shirley M. Francis.

The written acceptance of the said initial registered agent, as required by the provisions of Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.

SIXTH: The initial directors of the corporation shall be Shirley M. Francis and Nola Hall.

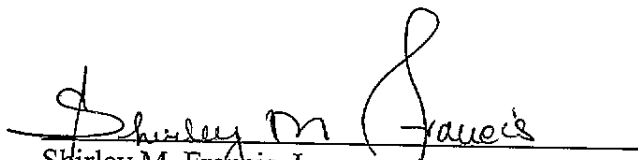
SEVENTH: The officers of the corporation shall be as follows:

EIGHTH: The corporation elects to have preemptive rights.

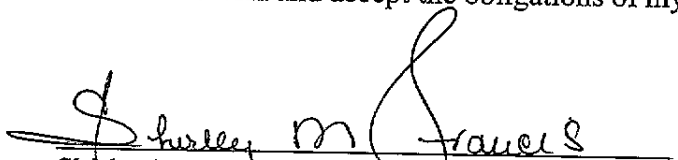
NINTH: The purpose for which the corporation is organized is to operate as a group home with permanent and respite clients.
