ARTICLES OF INCORPORATION OF DAVIS INVESTMENTS COMPANY, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

<u>Section 1.1</u>. <u>Name</u>. The name of this corporation shall be DAVIS INVESTMENTS COMPANY, INC.

Article II Principal Office and Mailing Address

<u>Section 2.1</u>. <u>Principal Office and Mailing Address</u>. The principal place of business and mailing address of this corporation shall be 295 Marsh Lakes Drive, Fernandina Beach, Florida 32034.

- <u>Section 3.3.</u> Approval of Shareholders Required for Merger. The approval of the shareholders holding sixty percent (60%) or more of the capital stock of this corporation eligible to vote to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.

Article IV Initial Registered Agent and Address

<u>Section 4.1.</u> Name and Address. The name and street address of the initial registered agent of this corporation is:

Article V Incorporator
