Article I

Name

The duration of the corporation shall be perpetual.

Nature of Business



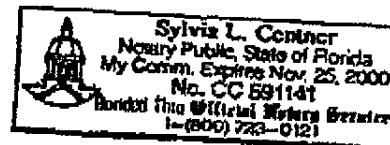
