ARTICLES OF INCORPORATION OF CRUISE SERVICES INC.

The undersigned, acting as incorporator under and by virtue of the laws of the State of Florida, and particularly the Florida General Corporation Act, as provided in Chapter 607, Florida Statutes, and any acts supplementary thereto, adopts the following Articips of Incorporation for such corporation.

ARTICLE I
