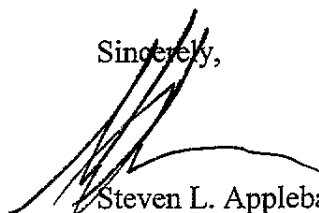

**Article I. Corporate Name and Initial Corporate Address**

**Article II. Nature of Business and Powers**

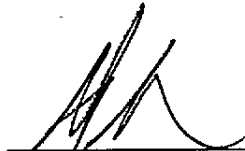

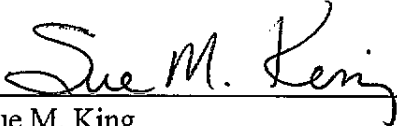
