ARTICLES OF INCORPORATION
OF
ROBERT ECKARD CONSULTING, INC.

The undersigned subscribers to these articles of incorporation, being duly licensed to health promotion, fitness training and exercise program design and consultation under the laws of the State of Florida, adopt these articles of incorporation under the Consumer Protection Act, Chapter 501, Florida Statutes, and other laws of the State of Florida.

ARTICLE I. NAME

The name of the health and fitness consulting corporation is Robert Eckard Consulting, Inc.

ARTICLE II. PRINCIPLE OFFICE

The principal office and mailing address of this corporation is 1606 Lago Vista Blvd., Palm Harbor, FL 34685.

ARTICLE III. PURPOSE.

ARTICLE V. CAPITAL STOCK

The capital stock of the health studio corporation shall be 1000 shares of common stock without par value.

ARTICLE VI. REGISTERED OFFICE AND AGENT

The address of the initial registered office of this health and fitness consulting corporation is 1606 Lago Vista Blvd., Palm Harbor, FL 34685. The name of the initial registered agent at that address is Robert D. Eckard.

ARTICLE VII. BOARD OF DIRECTORS.

ARTICLE IX. RESTRAINT OF SHARES

The shareholders of the health and fitness consulting corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the corporation by any of its shareholders, or in the event of death of any of its shareholders. The manner and form, as well as the relevant terms, condition, and details of the disposition shall be determined by the shareholders of the corporation; provided, however, that such regulatory or restrictive provisions shall not effect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock. No shareholder may sell or transfer stock in the corporation except to another individual who is eligible to be a shareholder of the health and fitness consulting corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting especially called for that purpose.

ARTICLE X. AMENDMENT

The corporation reserves the right to amend or repeal any provision of these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.


