ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

THE AFFINITY GROUP, INC.



Pursuant to Section 607.1006 of the Florida Statutes, THE AFFINITY GROUP, INC., a corporation organized and existing under and by virtue of the laws of the State of Florida (the "Company"), does hereby certify:

Name. The name of the Company is The Affinity Group, Inc.

Amendments Adopted. The amendment adopted provides for the Company to increase its authorized common stock from 15,000 to 25,000.

<u>Text of Amendments</u>. Article VI is hereby amended by deleting such Article VI and substituting the following new Article VI which reads as follows:

ARTICLE VI Capital Stock

The Corporation is authorized to issue Twenty-Five Thousand (25,000) share of Fifty Cent (\$0.50) par value common stock, which will be designated Common Stock.

Adoption of Amendments. The foregoing amendment was approved by unanimous approval of the Board of Directors and the shareholders of the Company pursuant to Sections 607.0704 and 607.0821, Florida Statutes, on February 20, 2001.

<u>Effective Date</u>. The effective date of the amendments herein certified shall be the date of filing these Articles of Amendment to Articles of Incorporation with the Florida Secretary of State.
