Selzee Solutions, Inc., a subsidiary of Dycom Industries, Inc. has been administratively dissolved for failure to file its annual report.

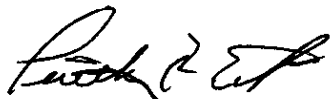
