The purpose of my letter is to bring to your attention the reason why my company, "CRUISEXCURSIONS.COM, CORP," has been assessed with a late filing fee.

After original receipt of the 2001 UBR earlier this year, we were asked by our legal representatives to deliver the report along with a check of \$150.00 to their offices on the understanding that they would handle the filing for us at this time.
