~~The purpose of my letter is to bring to your attention the reason why my company,~~
"CRUISEXCURSIONS.COM, CORP," has been assessed with a late filing fee.

After original receipt of the 2001 UBR earlier this year, we were asked by our legal representatives to deliver the report along with a check of \$150.00 to their offices on the understanding that they would handle the filing for us at this time. As the principles in our small company are new to the corporation process we felt it would be in our best interests to have a professional organization handle important matters such as this. To our great disappointment we discovered last week, after receiving the 'Important Notice' that the report was never filed.

We have approached the law firm representing us for an explanation as to their failure to file and are still awaiting an answer. This is why we have decided to take this matter into our own hands and contact you directly.

Having explained the circumstances surrounding this incident I do realize that the filing is entirely our responsibility regardless of who was at fault for the delay.
