**ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice medical under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, Florida Statute Chapter 621, and other laws of the State of Florida.

**ARTICLE I. NAME AND PLACE OF BUSINESS**

The name of the professional service corporation shall be: **FAMILY MEDICINE OF SOUTH TAMPA, P. A.** The principal place of business and the mailing address shall be 1502 South MacDill Avenue, Tampa, Hillsborough County, Florida 33629.

**ARTICLE II. NATURE OF BUSINESS**

This professional service corporation is formed to engage in every phase and aspect of the practice of medicine. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional medical services, and/or the practice of medicine.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this professional service corporation is authorized to have at any one time is 500 shares of common stock having a par value of \$1.00 per share.

None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice medicine in the State of Florida.

#### **ARTICLE IV. REGISTERED AGENT**

The initial registered agent of the professional service corporation shall be Caroline J. Tesche, Esquire, and the initial registered office of the corporation will be located at 1902 South MacDill Avenue, Tampa, Florida 33629.

#### **ARTICLE V. TERM OF EXISTENCE**

This corporation is to exist perpetually.

#### **ARTICLE VI. BOARD OF DIRECTORS**

It is the intent of the incorporator that the corporation will qualify under Section 1244 of the Internal Revenue Code and that the corporation may file as a Subchapter S corporation.

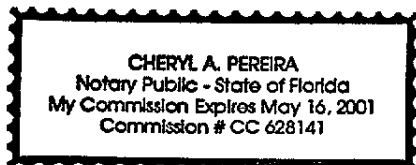
