**ARTICLE I.**

The name of this corporation is: I58, INC.

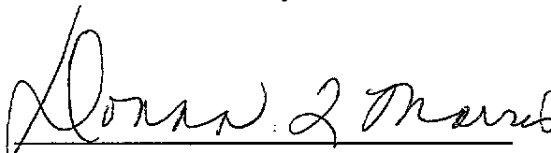

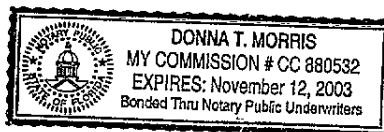
