These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of Heider Way, Inc., and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of Heider Way, Inc., and upon authority of all of the shareholders of this Corporation, hereby set forth as follows:

1. The name of this Corporation is Heider Way, Inc.
2. The Articles of Incorporation of Heider Way, Inc. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article:

"Article I

Section 1.1 Name. The name of this corporation is Heiderway, Inc."

In accordance with Florida Statute Section 607.1003, the referred to amendment was adopted by the Board of Directors on July 17, 2000, and written consent to the said Amendment was given on July 17, 2000, by all the shareholders comprising the only voting group in accordance with Florida Statute Section 607.0704.
