Article I. Corporate Name and Initial Corporate Address

The name of this corporation is **Studio Styles, Inc.**, and the initial corporate address is 2416 Lisenby Avenue, Panama City, Florida 32405.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.




