ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, Competent to Contract hereby form a corporation under the laws of the State of Florida.

ARTICLE ONE

CORPORATE NAME: The name of the corporation is: MIRROR IMAGE
DETAILING, INC.

ARTICLE TWO

DURATION: The corporation shall exist perpetually unless dissolved under Florida law.

ARTICLE THREE

PURPOSE: The corporation is organized for the purpose of engaging in any lawful activity or business permitted under the laws of the United States of America, and of the State of Florida.

ARTICLE FOUR

CAPITAL STOCK: The corporation is authorized to issue ONE HUNDRED (100) shares of common stock, par value of ONE DOLLAR (\$1.00) which shall be voting stock.


ARTICLE ELEVEN


