**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of WEST 50 GROVE, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**




