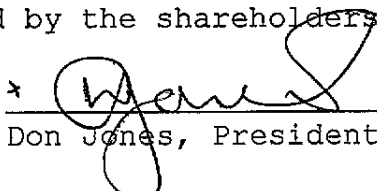

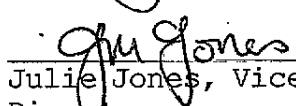
ARTICLES OF AMENDMENT

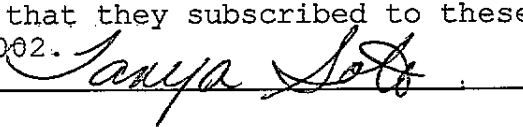
