ARTICLES OF INCORPORATION
OF
Underwriters Property Inspection, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be:

Underwriters Property Inspection, INC.

Article 2. Address. The location and mailing address of the principal office of the Corporation is 10811 - 70th Avenue North, Seminole, FL 33772.

Article 3. Authorized Shares. The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive net assets of the Corporation upon dissolution. The Corporation is authorized to issue 500 common shares.

June 01, 2000.



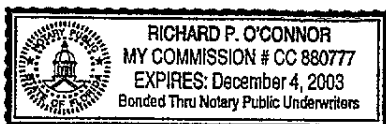


