ARTICLES OF INCORPORATION

OF

SAM REAL ESTATE ESTABLISHMENT, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of Florida.

1. NAME. The name of the corporation is SAM REAL ESTATE ESTABLISHMENT, INC.

2. PURPOSE. The purpose of the corporation is to include the transaction of any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

3. TERM. This corporation shall have perpetual existence.

4. ADDRESS. The address of the principal office of this corporation in the state of Florida is: 105 Robinson Street, Suite 310, Orlando, Florida 32801.

5. SHARES. The number of shares that may be issued by the corporation is 100 shares of common stock of the par value of Five Dollars per share. Sale of the shares shall be fixed in the By-Laws of the corporation, in full compliance with the laws of Florida.

6. CAPITAL. The amount of capital with which this corporation will begin business is Five Hundred Dollars.

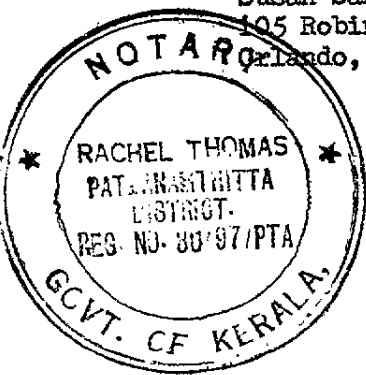

The specific duties of the officers shall be as set out in the By-Laws of the corporation.

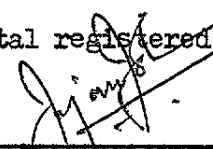
