ARTICLE I

NAME

INDEMNIFICATION

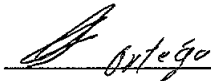
The corporation shall have the authority to indemnify any officer, director or member, or any former officer, director or member, to the full extent permitted by law.

AMENDMENT OF ARTICLES

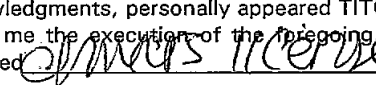

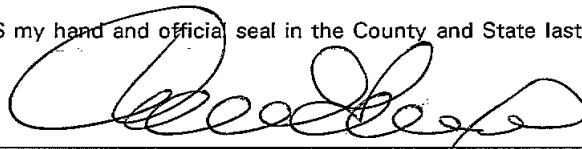
